- Call volume has slowed down from the previous month's increase.
- Found that we are applicable for another \$201K from Yolo County. I've created a spreadsheet to show proposed distribution of funds.
- Grant for \$10K received from California Firefighters Foundation. This grant was written to upgrade handheld radios to industry standard.

- Battalion Chief David Carveo presentation:
 - o Training
 - o Grant applications
 - Commercial Inspections
- Attempting to set up meeting with County personnel concerning Mel Smith Project at County Rd. 8
- Command vehicle upgrade Current vehicle lacks 4-wheel drive and has resulted in having to turn down
 tasks on large incidents. Used command vehicles available from \$15K and up. Funds were moved into the
 budget from the impact fee budget for this purchase but would like commission approval to move forward.
- Position changes:
 - Assistant Chief Eckels has accepted a full-time position with Stockton Fire and we decided it
 would be best to vacate his position as he needs to put his focus to his career for now. He will
 remain on the roster as an Engineer.
 - o Eric Sagara has accepted the assistant chief position to replace B. Eckels
 - o Dominic Norman has promoted to captain to replace the position formerly held by Sagara.
 - Angelo Bruschera has accepted a LT. position.
- Currently accepting applications for shift officer which will be a LT position. Interviews have been taking
 place, but no acceptable candidates have been found yet.
 - This interview process has been adjusted to include a second interview that will consist of neighboring chiefs that will need to work with our crews. I feel this will help avoid the possibility of poor personal relationships with our shift officers that need to interact with neighboring agencies in the absence of Assistant Chief Sagara or myself.
- Currently we are losing many reserves to academies but we are accepting applications and currently have at least 3 candidates waiting for the interview process. This level interview process is a single interview with 1 chief officer and at least 1 additional lower-level officer.
 - We've branched out our job advertisement process to include multiple internet locations as well as
 personal outreach and presentation to schools. School presentations will start after school is back
 in session, I have selected a senior reserve to conduct the presentations and one of our officers will
 accompany him if available.
